OFFICE ORDER

WHEREAS, Sri Manoj Kumar Das, O/o the District Audit Office, LFA, Jajpur has filed his objection through the Head of Office for entering the fact of passing all the Papers of Departmental Examination in the Gradation List. His case have been examined with reference to documents submitted i.e., Board of Revenue Department Notification No. 972/ Dt. 05.10.2015, 444/ Dt. 19.10.2016 & 1206/ Dt. 01.11.2017 & entries made in his service book by the concerned DAO and found to be correct and acceptable. Now, therefore, the said provisional Gradation List of Junior Clerks of LFA Organisation is hereby made Final with the above rectification and addition.


