**Sub:-** Submission of Certificate/ Undertakings regarding extension of time for utilisation of balance fund under 14<sup>th</sup> CFC.

**Ref:-** This Deptt. letter No- 7206 Dtd-18.04.2021 and Letter No-3974 Dtd- 07.03.2022

Madam/Sir

In inviting a reference to the subject and letters cited above, I am directed to say that it was intimated to utilise the unspent balance of Fourteenth Central Finance Commission (FFC) fund by 31.03.2022. During review of the Gram Panchayat wise unspent balance report from eGramSwaraj it is found that a sum of Rs 857.28 Crore is still showing as unspent balance as on 31.03.2022. The Gram Panchayat wise unspent balance report was provided to all the District during the UC review meeting of APD(Finance) held on 16.03.2022. Further, as per the unspent balance statement of 14<sup>th</sup> CFC, a sum of Rs. 168.46 Crore is shown as received by Gram Panchayats during the Year 2021-22. But no such funds under 14<sup>th</sup> CFC grant was released from State during the FY 2021-22. Due to wrong maintenance of account a huge amount of unspent balance is showing in the eGramSwaraj application.

In view of the above, you are therefore requested to reconcile the GP 14<sup>th</sup> CFC unspent balance as per Cash Book and Pass Book and submit a actual unspent balance as on 01.04.2022 in the annexed format along with the undertaking from Executive Officer, Zilla Parishad regarding the time required for 100% utilisation of 14<sup>th</sup> CFC unspent balance fund. This exercise may be completed within 7 days without fail and the undertaking to be submitted to this Department latest by 18.04.2022 positively.

These funds may be utilised as per the approved GPDP of 14<sup>th</sup> CFC of Gram Panchayat adhering to the specific guidelines as well as payment of outstanding energy charges of PWS to regularise the process.
