

As per Advertisement No. 223 dated 6-2-24 of Audit Office, Local Fund Audit, Bhubaneswar, the terms and conditions for re-engagement of retired Audit personnel to be engaged as OSD against vacant post of Auditor of this office are given below.

1. The applicant must be retired Audit personnel having computer skill and establishment knowledge and must not be more than 65 years old.
2. The retired Govt. servant against whom a vigilance case or departmental proceeding or criminal prosecution is contemplated or pending or who has been penalized for misconduct during the period up to five years preceding his/her retirement or is a member of a political party will not be considered eligible for re-engagement of OSD.
3. The contractual engagement shall be made for a period of one year or till joining of regular ministerial cadre employee against the vacant post whichever is earlier.
4. The retired Govt. servant after his re-engagement as OSD has to discharge such duties and in such a manner as may be prescribed by Audit Officer, LFA, Bhubaneswar from time to time.
5. The selection will be governed by the procedure and rules laid down in the GA & PG Deptt. Notification No. 23750/Gen dt.27.08.2014.
6. Consolidated remuneration of the contractual employee shall be fixed as per Finance Deptt. Office Memorandum No 24533/F dt.29.09.2022.
7. Copy of the 1st page service book, Retirement relieve order or pension pay order (PPO) & physical fitness certificate are to be furnished at the time of interview.
