OFFICE ORDER

No. 1472 /DLFA Dt. 24.02.2020
DLFA-FE-337/2013

Whereas, Superintendent of Police, Vigilance, Koraput Divison, Jeypore requested to the Examiner of Local Accounts-cum-Addl. Secretary to Govt, Finance Department, Bhubaneswar to accord necessary sanction as required u/s 19(1)(c) PC Act 1988 for prosecution against Sri Dileswar Dehury, Ex-Auditor, LFA, Komna Block, Dist-Nuapada, in Koraput Vigilance Case No.13 dt.31.03.2008 u/s 13(2) r/w 13(1)(d) PC Act 1988/418/420/468/120-B IPC instituted against Sri Dehury and other staff of Komna Block on the charge of showing undue official favour and causing loss of Government money to the tune of Rs.10,36,740/- in purchase of Water Coolers under MLA LAD Fund ;

And whereas, after carefully examining the facts and documents produced by the Investigating Officer, sanction as required under 19(1) (c) of PC Act, 1988 was accorded by Examiner-cum-Special Secretary to Government, Finance Dept vide Order No.10566/F dt.20.12.2010 for prosecution of Sri Dehury for the offence committed by him;

And whereas, Government of Odisha in G.A. (Vigilance) Department, Cuttack vide their letter No.509/V.Cr dt.10.02.2020 forwarded the copy of judgement dated 14.05.2019 of Special judge, Vigilance, Bhawanipatna in his judgement dt.14.05.2019 where the Special Judge, Vigilance Bhawanipatna has held accused Sri Dileswar Dehury, Ex-Auditor, Komna Block, Dist-Nuapada presently working in the O/o the District Audit Officer, Local Fund Audit, Sundargarh guilty of the offences u/s 13(2) r/w 13 (1) (d) P.C. Act,1988/418/420/468/120-B IPC, sentenced him to undergo rigorous imprisonment for 1 year and to pay fine of Rs.25,000/- for the offence u/s 13(2) r/w 13(1)(d) P.C. Act,1988, rigorous imprisonment for 1 year and to pay fine Rs.25,000/- for the offence u/s 418 IPC, rigorous imprisonment for 1 year and to pay fine Rs.25,000/- for the offence u/s 420 IPC, rigorous imprisonment for 1 year and to pay fine Rs.25,000/- for the offence u/s 468 IPC, rigorous imprisonment for 06(six) months and to pay fine Rs.25,000/- for the offence u/s 120-B IPC and in default of payment of fine for each of the offences the convict is to further undergo rigorous imprisonment for a period of 3(three) months and for 1 month for default of payment of fine for the offence u/s 120-B IPC. All the sentences shall run concurrently;

And whereas, One disciplinary proceeding was initiated against Sri Dileswar Dehury, Ex-Auditor, LFA, Komna Block, District-Nuapada presently working as Auditor, LFA in the O/o the District Audit Officer, Local Fund Audit, Sundargarh vide Finance Department Memorandum No.6880/F dt.31.07.2012 with charges like Dereliction in Duty and Failed to maintain absolute integrity;

And whereas, the S.P., Vigilance, Kopraput Divison, Jeypore vide their letter No.2132/VP-KPT dt.19.11.2012 intimated that the case has been charge sheeted vide No.04 dt.31.03.2011 U/s 13(2) r/w 13(1) (d) PC Act/418/420/468/120-B IPC against Sri Dehury;

And whereas, after creation of this Directorate on 01.10.2012, the Government in Finance Department vide their letter No.FIN-LFA-2-CASE-128/2012-10391/F dt.15.12.2012/07.11.2014 transferred the file relating to the aforesaid disciplinary proceeding to the Directorate of Local Fund Audit, Bhubaneswar for taking further action in the matter;

And whereas, the disposal of Disciplinary Proceeding was awaited by the Disciplinary Authority till disposal of the Vigilance case by the Court; and


Now therefore, considering the nature and character of the charges, as well as observation of the Hon'ble Supreme Court of India and provisions of Rule 18(i) of O.C.S. (CCA) Rules, 1962, Sri Dileswar Dehury, Auditor, LFA, the convict, is hereby dismissed from Government service with immediate effect under Rule 13 r/w Rule-18 (i) of OCS (CCA) Rules 1962 and Article 311 of the Constitution of India. The Departmental proceeding initiated against Sri Dehury vide Finance Department memorandum No. 6880/F dt.31.07.2012 for the same set of charges is disposed off accordingly.
