Whereas, one disciplinary proceeding under Rule 15 of the OCS (CCA) Rules, 1962 was initiated against Sri Satya Narayan Tripathy, Auditor, LFA who was working as a Executive Officer, N.A.C., Pipili with charges like Dis-obedience of the Orders of the Higher Authority, Un-authorized absence from Govt. duty vide this office Memorandum No.9998/DLFA dt.17.08.2016 with instruction to submit his written statement of defence, if any, within 30 days from the date receipt of the said Memorandum and also to state, if he desires to be heard in person; and

Whereas, the said Memorandum was served on Sri Satya Narayan Tripathy, Auditor, LFA at his residence by Sri Sudarsan Sahoo, Peon of this Directorate; and

Whereas, Sri Tripathy as per the instruction, submitted his written statement of defence on 14.09.2016 which was received in this office on dt.16.09.2016; and

Whereas, in the written statement of defence, Sri Tripathy categorically refuted the charges made against him on the grounds of ill physical condition and medical grounds; and

Whereas, in pursuance of the provisions of sub-Rule 4 of Rule 15 of the aforesaid Rules Sri Gatikrushna Satapathy, Deputy Director of this Directorate was appointed as Inquiring Officer and Sri Bichitrananda Naik, Assistant Director of this Directorate was appointed as Marshalling Officer vide this office order No.12452/DLFA dt.07.10.2016 to conduct inquiry and submit report within three months, and;

Whereas, the Inquiring Officer submitted his inquiry report on 14.07.2017 with suggestion for imposition of minor punishment and;

Whereas, as per the provisions of sub-Rule 10 (i) (a) of Rule 15 of OCS (CCA) Rule 1962, a copy of the inquiry report was supplied to Sri Tripathy vide this Office Notice No. 7846/DLFA dt.19.07.2017 calling upon him to submit his representation, if any, within 15 days from the date of receipt of the said notice against the findings of the Inquiring Officer; and

Whereas, the said Notice was served on Sri Debi Prasanna Tripathy F/o Sri Satya Narayan Tripathy at his residence by Sri Sudarsan Sahoo, Peon of this Directorate on 20.07.2017; and

Whereas, in pursuance of the aforesaid Notice, Sri Tripathy submitted his representation on 03.08.2017, which was received in this Directorate on dt.05.08.2017; and

Whereas, in his representation dt.03.08.2017, Sri Tripathy refuted the charges established by the Inquiring Officer on the ground of ill physical condition and self treatment due to accident and also prayed to accept his resignation w.e.f.30.07.2016 citing his physical inability to continue in service; and

Whereas, in pursuance of sub-Rule 10 (i) (b) of Rule 15 of OCS (CCA) Rule 1962, a copy of the findings of the Disciplinary Authority as well as proposed penalty was supplied to Sri Tripathy vide this office Notice No.9208/DLFA dt.14.09.2017 calling upon him to submit his representation, if any, within 15 days from the date of receipt of the said notice, against the findings of the Disciplinary Authority as well as proposed penalty; and

Whereas, the said Notice was served on Sri Debiprasana Tripathy, F/o Sri Satya Narayan Tripathy at his residence by sri Sudarsan Sahoo, Peon of this Directorate on 15.09.2017; and

Whereas, in pursuance of the aforesaid Notice, Sri Tripathy submitted his representation on 19.09.2017, which was received in this Directorate on 21.09.2017; and

Whereas, in his representation dt.19.09.2017, Sri Tripathy repeated his stand as per his earlier representation dt.03.08.2017 requesting to accept his resignation w.e.f.30.07.2016 and requested to make arrangements to disburse his arrear dues to maintain his livelihood and get relief from starvation.

Now, therefore, considering the nature of charges, findings and recommendation of the Inquiring officer, representations dt.03.08.2017 and 19.09.2017 of Sri Tripathy, the said disciplinary proceeding is concluded with the following punishments.

1. He is "Censured".
2. Stoppage of one annual increment without cumulative effect and
3. The period of absence from dt.13.09.2014 to dt.30.07.2016 be treated as leave due and admissible".
