

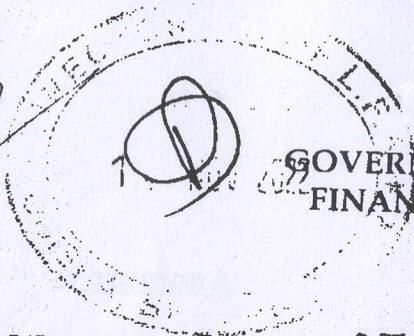


**Sub: Publication of Final Gradation list of Additional District Audit Officer/


