Sub: Verification of pension papers of employees of Local Fund Service.

Ref: This Office Letter No. 5850/DLFA, Dtd. 30.05.2013.

Sir,

In inviting a reference to the letter on the subject cited above, I am to say that in order to bring an improvement to the process of disposal of pension cases of LFS personnel and to render better services to them, it was suggested vide the said letter that the pension papers with Service Books of retired employees under Local Fund Service may be directly forwarded to the respective District Audit Offices for verification instead of forwarding the same to this Directorate for transmitting to the District Audit Offices concerned for verification.

But, it is observed that the pension papers and Service Books of retired LFS personnel are still being forwarded to this Directorate which, in turn, are being transmitted to the District Audit Offices concerned thus causing delay in finalising the cases. This can be avoided if the pension papers and Service Books are directly forwarded to the District Audit Offices concerned for verification.

Hence, enclosing a list of District Audit Offices and the ULBs under their jurisdiction, it is once again suggested that the pension papers and Service Books of retired L.F.S. personnel may be directly forwarded to the District Audit Offices concerned for verification under Rule 94 of the Orissa Local Fund Service (Pension) Rule, 1980 with intimation to this office.
